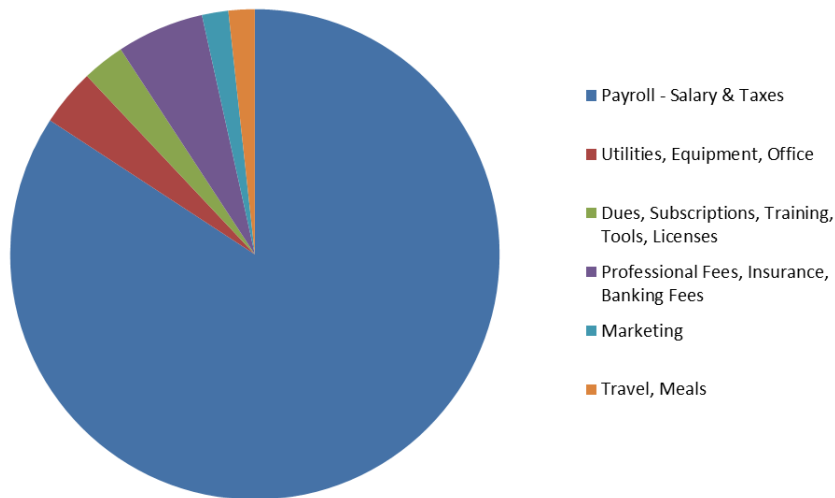

2008 to 2013 – Nonprofit leadership (development director, grant fundraiser). Early-stage consulting (fundraising, assessments).


2014 – Andi Kemp established the LLC - also a benefit company in Oregon – elected S-corporation status.

2017 – Transitioned to QuickBooks and hired a CPA. Added more planning and assessment projects. Restarted community training workshops. Began posting blogs. Provided more services to environmental, education and arts/culture nonprofits.


